# CITY OF NORTH LIBERTY, IOWA SUMMARY REPORT GOAL SETTING SESSION 2014

# **Introduction**

The City of North Liberty requested the Institute of Public Affairs (IPA) to assist the city with goal setting. IPA agreed to organize and facilitate a process that involved the following steps:

- 1. Prepare a questionnaire to identify recent accomplishments, issues/trends/concerns, potential new initiatives/programs/policies, and suggestions to improve organizational effectiveness.
- 2. Conduct a preliminary session with department heads.
- 3. Conduct a goal-setting session with the elected officials.
- 4. Preparation of a final report

## **Goal Setting Work Sessions**

City elected officials held a work session conducted by the IPA on January 20, 2014. In attendance and participating at this meeting were Mayor Tom Salm, City Council Members Gerry Kuhl (Mayor Pro-tem), Terry Donahue, Coleen Chipman, Brian Wayson and Chris Hoffman. Also in attendance and participating in this session was City Administrator Ryan Heiar.

A preliminary session was held with department heads on January 14, 2014. In attendance and participating in this session were City Administrator Ryan Heiar, Human Resource Director Deb Hilton, Communications Director Nick Bergus, Building Official Tom Palmer, City Attorney Scott Peterson, Interim Library Director Jennie Garner, Police Chief Diane Venenga, Wastewater Superintendent Dave Ramsey, Parks Director Guy Goldsmith, Recreation Director Shelly Simpson, Street Superintendent Don Colony and Assistant Fire Chief Bill Schmooke.

# **Major Accomplishments**

# <u>Issues, Concerns, Trends, and Opportunities</u>

The following were identified as issues, concerns, trends, and opportunities that may affect future city services, policies, finances or operations:

#### Budget/Finance

- New Property Tax law changes implementation/impact short and long term
- TIF curtailment by Legislature
- Increased costs to maintain infrastructure (More parks to mow, more staff needed, etc)
- Continued population growth equals continued increase in demand on city services and paying for them.
- Unfunded mandates by Legislature
- Increased cost for public safety
- Increased population and increased RUT is an opportunity for revenue
- Water/sewer rates becoming unaffordable
- Restructuring of Road Use tax formula
- TIF subtle encroachment on operational funds
- Increasing utility costs for city operations
- Health insurance increases

#### Infrastructure

- More rapid reconstruction of Highway 965 and Penn Street
  - o 965 Phase 2 traffic disruption is going to be a huge issue for businesses/travelers
- Push by ICCSD for infrastructure services and additional funding from city
  - o Annexation and development of Scanlon Farm driven by ICCSD
  - o Planning for new high school
  - o More New Schools Roads, Services, Maintenance
- Continued growth making sure infrastructure is in place before development is allowed get ahead of long-term infrastructure improvements
- Cost for development of Water/Sewer in Annexation Area and ROI
- Water Plant and Waste Water Plant new construction/additions
  - Need for expansion due to growth
  - o Cost and pass through to property owners/users
- Future IDNR regulations that affect the city's wastewater plant
  - o IDNR and the EPA are establishing future regulations without providing guidance on how they expect these new regulations to be met
- Need to encourage Coralville to develop a fixed timeline for 965 from Holiday Road to Forevergreen Rd. (Real bottleneck for NL)
- Storm water management
- Structural condition of ground storage tank
- Gravel Roads (Maintenance, Possible Upgrades)
- Keeping up with street, sidewalk and trail repair as they age
- Emergency power for wells

# Issues, Concerns, Trends, and Opportunities, continued

#### **Economic Development**

- Opportunity for eastward growth although the pace required for the school being built is an issue
- Lack of use of Council loan incentives for commercial development
- Development to the west of Hwy 965 driven by Centennial Park and UICCU

#### Public Safety

- Inadequate facilities for police and fire departments.
  - o At PD need more space to include the locker room, evidence, parking lot and a need for a briefing area or meeting space for all staff
- Increase in population- increases public safety concerns and the need for more officer training in order to stay ahead of the curve and demands on department
- An increase in violence against citizens and officers due to mental health and substance abuse issues
- Animal control issues. Examples: Picking up at-large animals, their temporary housing, release and follow up. Another issue is the handling of animal bites, and aggression animals
- Increased lawsuits involving law enforcement
- Continued changes in court decisions and the expectations of law enforcement
- Increases in the amount of time officers spend mediating civil issues.
- Inability to predict crime and need for extra manpower.
- Need for a jail, or structure where offenders can be temporarily housed
- Cost to fully outfit a police vehicle has become as much as the car itself
- Disposal of evidence after the cases have been dissolved.
- Snowmobile trails through city create problems for motorists

#### City Operations/Governance

- NL continuing to develop good reputation with surrounding communities and partnering more with them as growth demands.
- Increasing need for enforcement activities with growth, especially commercial
- School district agreements and shared use of facilities
- Need for additional staffing in some departments.
- Concern regarding the effect of union pay scale on non-union employees.
- Public perception of City government and employees.
- Increasing role in regional affairs, requiring more time commitment by elected officials

#### Other

- Need to continue to work on "green" practices, handicapped accessibility, and transportation in and out of the City (Does not need to be fixed route service).
- Explosive population growth and associated needs
- Expansion of farm animal ordinances
- With utility cost increases, opportunity for city to take renewable energy initiatives into consideration.
- Need to identify proposed uses for Ranshaw House
- Plastic bag ordinance

# **On-Going Commitments**

The following were identified as on-going commitments for the upcoming 24 month period:

- Highway 965
  - o Construction of Phase II
  - o Continue to identify outside funding sources, including federal funding, to implement Master Plan
  - o Continue to plan for future phases
  - Continue to provide on-going information/education to public regarding Highway 965 project
- Update Parks Plan; continue to plan and budget for playground equipment and restrooms in parks
- Lobby for federal funds for I-380 interchange projects, Penn St. bridge and Forevergreen Rd
- Ranshaw House improvements identify funding sources
- Review water and wastewater rates
- Phase I sanitary sewer upgrade Cherry St parallel line
- Centennial Park development
- Develop and implement program to improve police image
- Continue to evaluate need for infrastructure improvements in original part of city
- North Front St. reconstruction
- Sewer and water extensions /paving planning/financing easterly expansion of North Liberty
  - o Partner with developers on cost

# New Priority Projects, Programs, Policies and Initiatives

The participants reviewed potential projects, programs, policies and initiatives for consideration and selected the following as priorities for the upcoming 24 month period (listed in order of priority):

4 (Tie)	Rental/housing inspector position
4 (Tie)	Plan for City Hall/Police./Fire Dept. Campus
4 (Tie)	Citizen visioning program

# **Organizational Effectiveness Initiatives**

Mayor and Council reviewed and discussed a variety of ideas relating to improving organizational effectiveness to accomplish the selected goals and priorities. After this review and discussion, the following initiatives were to improve organizational effectiveness:

- Promote a sense of community and provide volunteer opportunities in the city.
- Promote programs and activities for senior citizens.
- Continue to hold City Council/Board and Commission work sessions to determine direction on major issues.
- Council to receive agenda packets for Parks, Library and similar boards.
- Better use of TV monitors in council chambers to post the items for public either by major title and to show physical plans/sites by developers, etc. (Do not need to show consent agenda as too long).
- Online police blotter so public is aware of what is going on.
- Continue to expand online request for services for public.
- Personnel policies review/update/be more uniform where appropriate.

#### **Final Comments**

It was a pleasure to again assist the City of North Liberty with this goal setting process. I continue to be extremely impressed with the level of cooperation and positive attitudes of the elected officials and staff.

It is important to note that the prioritization of projects and initiatives is not "cast in stone." They can be modified as new circumstances may occur.

It is recommended that staff prepare an "action plan" for accomplishing the planning goals. The action plan would define the steps that would be needed to accomplish each goal, identify who is responsible for implementation, and establish a timeline for accomplishment. The action plan should then be presented to the City Council for review and approval. It is also recommended that staff review with the City Council the status of implementing the goals on a quarterly basis.
