Micromobility Devices (E-Scooter) Ordinance

Staff is seeing more and more electric, non-bicycle type devices on the City's streets, sidewalks and trails. These devices include, but are not limited to, e-scooters, e-skateboards, e-unicycles, etc. In an effort to regulate these devices for the safety of the users, pedestrians, and other right-of-way users, staff recommends amending Chapter 76 of the City Code to include provision regarding electric micromobility and personal assistive devices. The amendment adds definitions and outlines requirements for the use of these devices on public rights-of-way. Some of the more significant regulations in the proposed ordinance include maximum speed, use of lights, and areas of operation. Staff recommends approval of the ordinance amendment.

North Liberty Community Pantry CDBG Application

It was discovered that the public hearing notice for the March 12 public hearing was not published. As a result, the City Council must hold the hearing and approve the accompanying resolution once more.

The North Liberty Community Food Pantry is requesting assistance with a Community Development Block Grant Application that, if funded, would provide them with \$100k for fresh food purchases. As proposed, the City will submit the application, which is being prepared by East Central Iowa Council of Governments (ECICOG), and act as a conduit for funding should the application be approved. Since the administration of the grant will be handled by ECICOG, the staff time needed to potentially leverage \$100k for the

Pantry is minimal. Staff recommends proceeding with the application and approval of the related resolution.

Linn County REC Easement Sharing Agreement

Some time ago, North Liberty acquired a large sanitary sewer and public utility easement from TL & L Inc. running along portions of Forevergreen Road and Jones Boulevard. The easement allows the City to elect to share space with other utilities in its discretion. Linn County REC has requested to use a portion of the existing easement on Jones Blvd to provide additional service to the University of Iowa Hospitals and Clinics facility. Staff have drafted an agreement which sets forth the parameters for such use, and recommends approval.



E-Scooter Ordinance

ORDINANCE NO. 2024-02

AN ORDINANCE AMENDING CHAPTER 76 OF THE NORTH LIBERTY CODE OF ORDINANCES CONCERNING THE OPERATION OF ELECTRIC PERSONAL ASSISTIVE AND MICROMOBILITY DEVICES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LIBERTY, IOWA:

SECTION 1. NEW SECTIONS. Chapter 76 of the North Liberty Code of Ordinances is amended by adding the following new sections:

76.13 ELECTRIC PERSONAL ASSISTIVE AND MICROMOBILITY DEVICES DEFINED.

- 1. "Electric personal assistive mobility device" has the same meaning as set forth under Iowa Code § 321.1(20B).
- 2. "Micromobility Device" means any device not an electric personal assistive mobility device and not a bicycle or low-speed electric bicycle, designed to carry one rider or operator, where such device is equipped with an electric motor of less than seven hundred fifty watts, and where such device is not required to be licensed or registered by the State of Iowa. Micromobility devices may be propelled either by the power of the rider or by an electric motor or a combination thereof. Micromobility devices include, but are not limited to, electric unicycles, electric tricycles, electric stand-up scooters, electric sit-down scooters, and motorized skateboards.

76.14 SAFE OPERATION OF ELECTRIC PERSONAL ASSISTIVE AND MICROMOBILITY DEVICES.

- 1. Electric personal assistive mobility devices may be operated on sidewalks and bikeways in accordance with this section and the provisions of Iowa Code § 321.235A.
- 2. Micromobility devices may be operated on sidewalks and bikeways in accordance with this section.
- 3. A person who operates an electric personal assistive mobility device or micromobility device shall exercise caution to avoid colliding with any pedestrian, shall yield the right of way to any pedestrian, and shall not operate the device in such a manner as to indicate a willful or wanton disregard for the safety of persons.

- 4. It shall be unlawful for any person to operate an electric personal assistive mobility device or a micromobility device upon any publicly owned property at a speed greater than 20 miles per hour.
- 5. No person shall operate an electric personal assistive mobility device on any roadway, except for designated bikeways and traversing the roadway at marked pedestrian crossings.
- 6. No person shall operate a micromobility device on any roadway unless the person possesses a valid driver's license and obeys the rules of the road.
- 7. Prohibited Operation: No person shall operate a micromobility device upon any road with a posted speed limit greater than 25 miles per hour.
- 8. All electric personal assistive mobility devices and micromobility devices used during the hours from sunset to sunrise shall display or their drivers shall wear a lamp on the front part of the device, and the lamp shall emit a white light visible from a distance of at least three hundred feet (300') from the front of the device and a red visible light from a distance of at least three hundred feet (300') from the back of the device.

76.15 AUTHORIZED POLICE DEVICES. An on-duty police officer operating a duly authorized Police Department bicycle, electric personal assistive device, or micromobility device may, when necessary, in the performance of his/her official duties, operate or park such bicycle, electric personal assistive device, or micromobility device contrary to the provisions of this Chapter. The foregoing provision shall not relieve the operator of an authorized bicycle, electric personal assistive device, or micromobility device of the duty of operating with due regard for the safety of all persons nor shall such provision protect the operator from the consequences of his/her reckless disregard for the safety of others.

76.16 PENALTY. Violations of this chapter are a simple misdemeanor punishable by a fine of twenty-five dollars (\$25.00) for a first offense. Second and subsequent offenses are simple misdemeanors punishable in accordance with the standard city criminal penalty set forth in Chapter 1.14.

SECTION 2. REPEALER. All Ordinances and parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 3. SCRIVENER'S ERROR. The correction of typographical errors which do not affect the intent of the ordinance may be authorized by the City Clerk or the Clerk's designee without further public hearing.

SECTION 4. SEVERABILITY. If any section, provision or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 5. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

A RESOLUTION APPROVING A GRANT APPLICATION FOR COMMUNITY DEVELOPMENT BLOCK GRANT CORONAVIRUS (CDBG-CV) FUNDS TO PURCHASE FRESH FOOD AND ADOPTING THE STATE OF IOWA CDBG-CV DUPLICATION OF BENEFITS (DOB) POLICIES AND PROCEDURES FOR THE CITY OF NORTH LIBERTY

WHEREAS, the City of North Liberty, Iowa, (hereinafter referred to as "City") has determined a need for additional fresh food in response to increased demand for food following the COVID-19 pandemic at the North Liberty Community Food Pantry; and

WHEREAS, direct food supports, e.g. free school lunches and increased EBT funds, to families in response to pandemic have ended; and

WHEREAS, the City desires to meet the demands for food security and provide more fresh food options for households; and

WHEREAS, an application has been prepared to request funding from the CDBG-CV Program in the amount of \$100,000 to purchase approximately 450,000 pounds of food; and

WHEREAS, the City Council is required to ensure that Duplication of Benefits (DOB) does not occur with the utilization of CDBG-CV funds; and

WHEREAS, it is now procedurally necessary to adopt the State of Iowa CDBG-CV DOB Policies and Procedures via resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of North Liberty, Iowa, that the above-referenced CDBG-CV application and all necessary forms are hereby approved and the above-referenced State of Iowa CDBG-CV DOB Policies and Procedures be and the same are hereby adopted.

PUBLIC UTILITY EASEMENT SHARING AGREEMENT

WHEREAS, the City of North Liberty, Iowa ("City") was the Grantee of a permanent easement pursuant to a Public Utility Easement Agreement between it and T. L. & L., Inc. dated February 9, 2007, and recorded March 1, 2007, in the records of the Recorder, Johnson County, Iowa;

WHEREAS, said Public Utility Easement Agreement provided that "[s]aid permanent easement may also be used for other public utilities in the City's discretion and by its direction...";

WHEREAS, the Linn County Rural Electric Cooperative Association ("LCREC") requests to share a portion of the permanent easement for installation of electrical lines for distribution of electric energy; and

WHEREAS, the City has agreed, it is discretion to share a portion of the permanent easement with LCREC under the following terms and conditions:


- 1. LCREC shall share the portion of the permanent easement described as the West 5 feet adjacent to the Jones Boulevard right-of-way line from the point of beginning of the permanent easement, then south along the Jones Boulevard right-of-way to the point when the easement turns east, all in the NW¼ of Section 24, Township 80 North, Range 7 West of the 5th P.M. of North Liberty, Johnson County, Iowa as shown on Exhibit A attached hereto.
- 2. LCREC shall have the right, privilege, and non-exclusive license to enter in and upon the described portion of the easement to install, maintain, replace and remove electric lines or conduit below the surface of the ground for the distribution of electric energy, including without limitation all appropriate wires for the distribution of electric energy ("Facilities"). This license does not extend to work performed in City right-of-way, which requires a separate permit. LCREC agrees to exercise reasonable care in working around and protecting existing City utility facilities in sewer easement areas, which

includes portions of the sanitary sewer system, storm intakes, storm pipes, and fire hydrants. LCREC further agrees to coordinate with the City and the University of Iowa Board of Regents in coordinating the location of utilities in the area of a proposed traffic signal for the University of Iowa Hospital Facility to be installed on Forevergreen Road between Highway 965 and Jones Boulevard.

- 3. The Facilities described above shall remain the property of LCREC. LCREC shall have the right to inspect, rebuild, remove, repair, and improve in and to its Facilities as it may from time to time deem advisable.
- 4. For the purposes of installing, inspecting, maintaining, or operating its facilities, LCREC shall have the right of ingress and egress to the portion of permanent easement over lands adjacent to the easement and lying between public roads and the easement, such right to be exercised in such manner as shall occasion the least practicable damage and inconvenience to the landowner and the City.
- 5. LCREC shall be bound by same obligations as the City to T. L. & L., Inc. provided in said Public Utility Easement Agreement referred to above regarding the portion of permanent easement described in Exhibit A.
- 6. LCREC shall, at its own expense and without compensation, relocate the Facilities as the City may reasonably require for the purposes of facilitating the construction, reconstruction, maintenance or repair or any public improvement of Jones Boulevard adjacent to the easement area. Notice of such relocation request shall be given in the same manner as provided in North Liberty Code Chapter § 117.05.
