***This pet license is only required for pets of residents who live within North Liberty (Iowa) city limits*** per North Liberty Code of Ordinances Chapter 56 titled "Cat and Dog Licenses"; if you live outside of city limits, please check for the pet licensing requirements of your jurisdiction.

A pet license tag and a photocopy of this application will be mailed to the pet owner after application, necessary documentation, and payment have been received. The pet license fee is \$25 per pet per year (excepting a rate discount for service animals and persons 62 years old or older); however, if your pet is spayed or neutered and maintains a current rabies vaccination, then annual license renewals are free. Allow ten (10) business days for processing and delivery.
