a current Pet License for their dog prior to applying for a park pass.

DOG PARK RULES

Dogs Must

Be at least 16 weeks old to enter.

Be vaccinated for rabies.

Not be in heat.

Not be feeling sick or have a communicable disease.

Not be deemed "vicious," "dangerous," or "aggressive" by the City or other municipality.

Stay visible to your human at all times and be ready to listen to a command.

Leave if you are involved in a reportable incident, whether as the instigator or the target.

Humans Must

Be at least 16 years old to enter; if under 16, you must be accompanied by a responsible adult (over 18 years old).

Not be feeling sick.

Not be handling and/or responsible for more than two dogs.

Carry a leash for each dog. Dutifully use a leash on your dog(s) before entering and after leaving a yard, but must remove while dog is in yard.

Clean up after the dog(s) in your care.

Not conduct lessons or other for-profit activities on park property.

Stop displays of dominance, charging, excessive barking, hole-digging & bullying.

Be responsible for your dog's actions and behavior at all times.

By passing through the gates into the park yards, you agree to abide by the park, yard, human & dog rules posted at the Red Fern Dog Park and found online in more detail at northlibertyiowa.org/dogpark. Use of the park is at your own risk.

"Dusk" - when the earth has gotten fully dark, which happens about 60 minutes after sunset.

Park closes at dusk.

This rule allows people to enjoy the park in the evening during seasons with early sunset.

Vehicles left in the parking lot after dusk will be towed at the owner's expense.



PROHIBITED ON GROUNDS

Alcohol

Cigarettes & e-Cigarettes

Glass

Electronic Training Devices, without approval from Animal Control or their designee

Pronged, Pinch, or Choke Collars

Human Food (except nonalcoholic beverages) Dog Food (except small training treats)

Wheeled Devices (except wheelchairs, strollers & medical assistance devices)

Large Personal Items (like a chair or duffle bag that could pose a tripping hazard)
